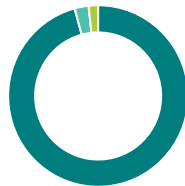

Geographic allocation (%)

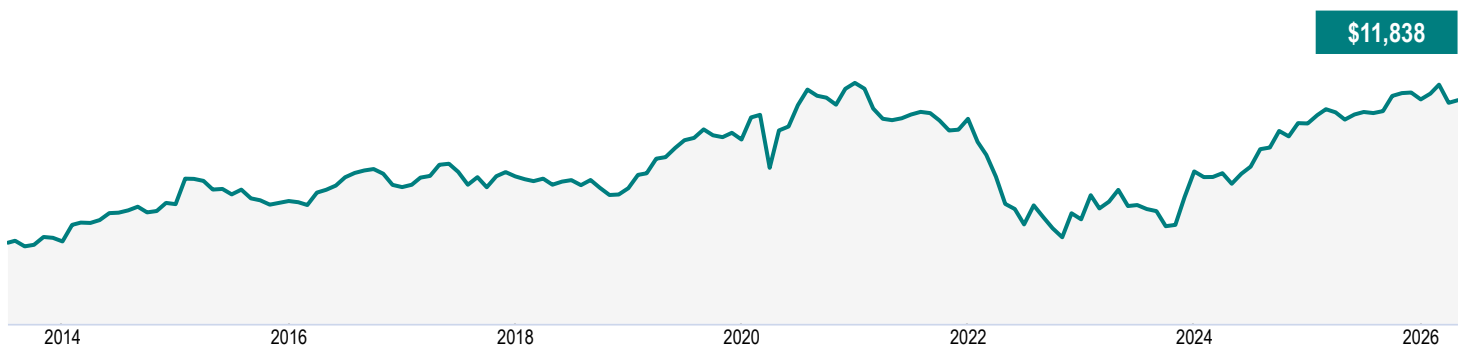
